**Subject:** *Health and Wellness Centers (UPHCs, PHCs, Urban HWCs, SHCs, AHWCs)-a Elderly Care (kum upa te enkawlna) pek dan tur chungchang in hriattirna.*

Sir/ Madam,

Ministry of Health & Family Welfare chuan kum 2010 khan “National Programme for the Health Care of Elderly” (NPCHE) programme a din a. He Elderly Programme hian kum 60 chunglam te'n hrisel taka hun an hman theihna tura an mamawh inenkawlna leh tanpuina te a theih anga pek a tum a.

Kum 2022 khan Health and Wellness Centers (UPHCs, PHCs, Urban HWCs, SHCs, AHWCs) level-a hman tur Elderly care chungchang Guideline chu rawn ti chhuak lehin Medical Officers te, Staff Nurses leh SC-HWC a thawktu zawng zawng heng - Health & Wellness Officers te, ANM/MPW te leh ASHA te training pek vek tur a ni a. Heng a hnuia Guidelines kan rawn tarlan ang hian Health and wellness Centers zawng zawngah tha taka kalpui a nih theih nana hma min lo lakpui tur in ka ngen a che.

A hnuia tarlan ang hian kum upate dinhmun hi thliar hran a ni, an dinhmun tarlan ang hian tanpuina leh ngaihsak an mamawh dan a hriattheih a ni.

1. **Mobile Elderly:** Mahni duh dana che sawn thei.
2. **Restricted mobile elderly:** Midang tanpuina emaw, khawl hmanga che sawn thei (e.g. wheelchair/Walking aids hmang)
3. **Bed bound:** Khum beta awm (Natna khirh tak avang emaw natna vang ni kherlo)

**Elderly Population-Based Screening kalpui dan tur: -**

1. **Elderly population enumeration:** ASHA chuan CBAC Family Folder a fillup atangin kum 60 chunglamte a chhinchhiah ang.
2. **Elderly Care Register:** Register hranah Elderly population te chu ziah luh tur a ni. (Annexure-III)
3. **Assessment of Elderly:** ASHA worker chuan Health worker kaihruaina hnuiah kum 60 chunglam zawng zawng te tlawhchhuah a, Annexure II hmanga assessment neih tur a ni.
4. **Identification of care-giver availability:** ASHA chuan kum 60 chunglam mahnia cheng, enkawltu mumal neilo te chu zawng chhuakin Sub Health Center emaw Primary Health Center ah report tur a ni a, HWC team ten puih thei dan an ngaituah ang.

5. **Health assessment:** Taksa hriselna kawnga pui thei tur, insawizawi pawimawh zia te, ei leh in uluk a tul zia te chu ASHA leh HWC team te'n an hrilh hre tur a ni a. Kum upatna in a ken tel BP sang, Zunthlum leh Hb hniam te an nei em tih zawh tur a ni.
6. **Comprehensive Geriatric Assessment:** Annexure II - Comprehensive Geriatric Assessment tool hmang hian kum 60 chunglam te chu house to house assessment neiha an mamawh anga enkawl zui tur a ni. He assessment hi kum 1-ah vawi 2 tal neih tur a ni.
7. **Home Assessment kit:** (Annexure-I) te hi Home Visit neih apiangin ken tur a ni.

### **Level hrang hrang Elderly Care pek dan tur:**

#### **Community Level - ASHA te mawhpfurhna:**

1. ASHA chu khawtlang hruaitu - VHSNC, MAS, JAS, NGO hrang hrang (e.g. MUP) leh Self-Help group te nen thawk hoin kum upate hrisel nan leh an bulhnaia tar chaklo zawk te dinhmun ngaihven thin tur a ni.
2. **Passive Physiotherapy Services:** ASHA chuan CHO kaihruaina hnuiah khumbeta awm tar chaklo zual te chu Passive Physiotherapy Services (eg. Massage, Vur/Tui vawt/lum a deh.etc) an pe thin tur a ni.

#### **Community Level - HWC Team (ANM/MPW/CHO) te mawhpfurhna:**

1. **Elderly Support group:** Elderly Support Group - “Sanjeevini” tih hming pu an din tur a ni a, he pawl member atan hian heng -VHSNCs, MAS, JAS leh NGO hrang hranga hruaitute hi telh tur a ni. He pawl member te hian an chhehvela tar chaklo puih ngai te chu lo zawngchhuakin Sub Center-ah an report anga a tul angin HWC team ten an lo buaipui thin ang. Thla tin meeting neiin pawl kal zel dan tur an rel thin ang.
2. **Home visits for elderly:** HWC Team-te chuan khumbeta awm tar chaklo zual leh natna khirh tak tuara in lama inenkawl mek te chu tlawhchhuahna hun a siam anga, damlo enkawltu leh an chhungte chu fuih a, enkawl dan tur tha te hrilh hriat thin tur a ni. (e.g. *damlo mu reng chuan bed-sore te an nei thei a, chumi an neihloh nana enkawl dan te leh hliam tenau an neiha enkawl dan te an hrilh hre tur a ni.*) Home visits apianga care pek/counselling pek te chu Elderly Care Register-ah Annexure III ang hian record siam tur a ni.

#### **HWC- Sub Health Center/AHWC Level: -**

1. **Teleconsultation:** SC-HWC/AHWC chuan natna serious tawh a rang lama enkawl ngaite chu PHC-a Medical Officer hnenah a refer anga, a tul dan ang a teleconsultation tih sakin MO treatment pek angin a enkawl ang
2. **Wellness session:** Mahnia kal thei te chu HWC-a activity session thlatin a neih thinah an kal theih nan hma an la ang a. HWC a kal thei lo an nih chuan inlamah HWC team ten Physical activity (Exercise lak pui) emaw, physiotherapy an neih pui thin ang.
3. **Special Clinic for Elderly:** Thla khatah vawi khat tal ni bik siamin Elderly Clinic huaihawt tur a ni a, heng ah hian JAS/MUP te nen emaw tangkawpa hun remchang ah Special clinic neih thin tur a ni. SC bial tu MO emaw te nen a theih chuan ruahhmannaa siam ho ni se.
3. **Elderly Care Register:** Damlo te chanchin leh Sub Center-a inentir tura lo kal te chu Elderly Care Register-ah felfai takin a record zel ang a, home visit-a care pek te pawh uluk taka chhinchhiah tur a ni. Kum 60 tling tawh te chu inentir fo tur a fuih tur a ni.

4. **Nutritional support:** Ei leh in tur tha nei lo leh ei thalo te chu Oral supplemental nutrition pek a, chaw, thlai leh thei hrisel an theih anga tam ei an mamawh tawh zia te hrilh tam tur.
5. **Counselling for Healthy Living:**
  1. Natna benvawn nei leh damdawi ei reng ngai ang chi ho te damdawi ei that pawimawh zia zirtir
  2. Ei leh in hrisel te leh zuk leh hmuam tih that loh zia te zirtir
  3. Prosthetic/machines e.g. Bengdar vuah duh lo, Ha lem vuah duhlo, tarmit vuah duhlo te zitirna pek

#### **CHO kaihruaina hnuua Primary Health Care Team te mawhphurhna:**

1. **Training of Care-giver:** Khumbeta damlo enkawltu (care giver) te chu fuihin, enkawlna tha zawk damloin a dawn theih nan basic nursing skills (eg. Hliam tenau enkawl dan.etc) an zirtir thin ang.
2. **Diet counselling:** Enkawltute chu damdawi ei dan tur leh ei hunbi te chiang taka hrilh hriat tur a ni a. A tul dan angin Supplement/vitamins-te leh SC-a damdawi dawn theih te a hrilh hre tur a ni.
3. **Home based care:** Kum upa natna khirh tak tuar, in lama inenkawl mekte chu an mamawh ang enkawlna in lamah an pe thin ang, an mamawh ang Physiotherapy an tihsak ang.
4. **Fall risk environment:** In leh lo leh a chhehvel a tar chaklo zawkte tlusualna thlen thei thil awm te khawtlang huapin zirtirna pek tur a ni. (eg. In kawt tinaltu patek awm tihfai te, Floor tiles nal chi bathroom leh kawta hmanloh etc)
5. **Emotional support for care-givers:** Khum beta mu damlo natna khirh tak tuarte chu an chhungte rilru hahna leh natna te thawidam turin an hnemin an fuih thin ang.
6. **Community level awareness:** NGO hrang hrang te leh Self-help group ten nen thawk ho in, hriselna kawng hrang hrang te, faina chungchang te, ei leh in hrisel te, thil chin thalo chungchang te leh upa te ngaihpawimawh leh enkawl dan chungchang ah te awareness huaihawt thin tur a ni.
7. **Elderly Day Celebration:** October ni 1 hi Kum upa te ni '**Elderly Day**' a nih angin kumtin October thla apiangin HWC ah Health Mela (kum upa tan a thlawn a in check-up) neih thin tur a ni.






