TERMS & CONDITIONS

- Authorized Distributors/Stockist or agents should furnish Photo copy of their Distributorship or Stockist or Agencies Certificate duly attested by a Gazetted Officer or Notary and should produce Original Certificate at the time of opening the tender, if demanded.
- All pages of the tender should be duly numbered and page index maintained at the first page of the tender document.
- Quotation of rates with name of manufacturer and brandname etc. should be submitted in the

- 7.
